## League Secretary's Report:-

#### 2014 Summary

In mixed division 1 Hutton & Shenfield beat Grosvenor by 1 point

# Formation of the league 2015

The mens and the ladies sections had become a little unbalanced so I have had to adjust some of the divisions. I have based my decisions on the teams' relative performances within their own division.

In the mens section I have promoted 3 teams from mens division 2, and 3 teams from mens division 6. I have not relegated any teams from mens division 3. Three new teams have gone into mens division 6.

In the ladies section again to balance the divisions I have relegated 2 teams from ladies division 1 one of them being Clearview. However, Clearview ladies won division 2 so I have left both teams where they were.

In the ladies and the mixed sections I debated whether to make it three divisions of eight teams or four divisions of six teams as we currently have. I decided to leave it as it is.

# **Proposed Rule Changes**

• League secretary proposed a change to the wording of rule 11 Promotion/Relegation.

Replace the text "at the AGM" with "by the league secretary" so that it reads "Promotion and regulation between divisions shall be on the basis of two up, two down (except between division 1 and 2 where only one team will move up or down), or as may be decided by the league secretary".

A vote was taken and the rule change was accepted.

League secretary proposed a change to the wording of rule 7 Eligibility of Players.

Delete the text "nominate and" so that it reads "Each player shall be a bona fide playing member of an affiliated club".

A vote was taken and the rule change was accepted.
