### **Any Other Business**

PC informed the meeting that any discussions tonight, even if passed, would not apply to the season ahead (2025-6). As clubs would need to be notified in advance of potential rule changes which hadn't happened. Instead, noted made tonight would be passed to VO for clubs consideration at next years AGM, ahead of the 2026-7 season.

The Following was raised for discussion;

#### a) Start times

A request to start all matched at 7pm rather than 7.30pm. As later start times result in a later finish. Which, together with travelling home, is getting too late. Several clubs spoke in response -

- Courts not available until 7.30pm, often due to coaching.
- Difficulty for players getting to matches after work, causing late arrivals.

PC suggested that during the year VO circulate all clubs for consideration and report back.

# b) League Structure

A request for consideration to be given to re-distribute the number of teams in some divisions. Pointing our that some divisions had become uneven with teams withdrawing.

PC explained it was too late to change the "proposed League structure" for the 2025/6 season as any changes need careful consideration. So would pass this on to VO for next year.

# c) Renaming of Teams

Stock announced that their teams would be numbered (1&2) instead of (A&B).

# d) Proposed League Structure

PC read carefully through this, division by division, as there had been a number of changes since circulation by VO before her holiday. All changes he was aware of were highlighted. A couple of further changes were pointed out and announced.
